The adjudication of bids will be done in terms of the Preferential Procurement Regulations, 2011 Pertaining to Preferential Procurement Policy Framework (Act No. 5 of 2000) and will be based on the functionality and 80/20 points systems using CIDB Method 4. Bidders are required to submit their valid B-BBEE status level of contribution certificates in order to claim for preference points.
