Only contractors with an active CIDB Grading as indicated above will be allowed to participate in the bid. The adjudication of bids will be done in terms of the Preferential Procurement Regulations, 2011 Pertaining to Preferential Procurement Policy Framework (Act No. 5 of 2000) and will be based on the functionality and 90/10 points systems using CIDB Method 4. Bidders are required to submit their valid B-BBEE status level of contribution certificates in order to claim for preference points.

**Functionality:** Points will be allocated as follows;

Proof of surety from a recognised financial institution. (Intention to provide surety)	20 points
